I. Outline of the Master of Science in Sustainability

UNU-IAS offers master's programme focused on sustainability. The programme aims to produce the policymakers and researchers of tomorrow, who will be at the forefront of global efforts towards a more sustainable future. The programme takes an transdisciplinary approach to providing the analytical and technical skills needed to advance creative solutions to issues of sustainability. Studying at UNU-IAS brings the unique benefits of:

- Collaborative research & practical experience,
- A global university within the UN system, and
- An international and interactive learning environment in central Tokyo.

The Master of Science in Sustainability programme is a two-year programme, which provides students with the knowledge and practical skills necessary to contribute to solving challenges of sustainability. Drawing on an innovative, interdisciplinary approach, the programme integrates methods and resources from the natural and social sciences, as well as the humanities.

The programme is intended for recent graduates, professionals and practitioners who seek to meaningfully contribute to the work of governments, civil society, the private sector, and/or the UN and other international organizations in the area of sustainability.

The programme builds on UNU's strong record in research and capacity development, as well as the extensive network of scholars and academic institutions participating in UNU research. The programme is practice-oriented, user-focused, and of the highest academic quality. It provides students with unique opportunities to interact with leading scholars and policymakers through lectures, international conferences, and workshops.

The academic year starts in September. By July of the second-year students must fulfill the course requirements, obtaining at least 30 credits and completing a thesis. Students can select courses from those offered by UNU-IAS, while also enjoying the opportunity to take courses at other leading universities in Japan such as the University of Tokyo, Sophia University, and International Christian University.

A Focus on Sustainability: Our Thematic Areas and Research Opportunities

The UNU-IAS postgraduate programme are closely interconnected with institute's research activities. Students have opportunities to gain practical experience by engaging actively in the research projects in UNU-IAS thematic areas. The Courses offered correspond to these thematic areas under the overarching theme of sustainability.

- Governance for Climate Change and Sustainable Development (GSD)
- Biodiversity and Society (BDS)
- Water & Resource Management (WRM)
- Innovation & Education (IVE)

Applicants are required to choose one of these thematic areas and propose relevant research to conduct at UNU-IAS. A description of each area is available on the [thematic areas](#) page.

Student research is expected to contribute to the project with which the student chooses to be affiliated. Students hone skills learned in the classroom by conducting research in the field alongside experts and experienced practitioners.

Faculty

The programme is taught by an expert teaching faculty comprising both UNU-IAS academic staff and invited distinguished scholars and practitioners. Please see the list of faculties members [here](#).

Programme Programme Structure & Language

The programme is offered on a full-time basis only. The standard period to complete the degree requirements is 24 months or four academic semesters, excluding time spent on study leave of absence from the university. The Master of Science in Sustainability degree is awarded upon satisfactory completion of 30 credits and a master's project.

The language of instruction is in the **English**.

The Master of Science degree programme in Sustainability shall be made of thirty credits. A master's thesis project is required for completion of the degree.

Climate Action for the Paris Agreement

Under the GSD specialisation, the Master's programme also aims to enhance capacity for implementing the Paris Agreement and provide a practicum training opportunity in collaboration with global partners, with the purpose to contribute to their own country's climate policy objectives through the implementation of the Paris Agreement. Enrolled students can earn the diploma of Master's degree with concentration of Governance for Climate Change and Sustainable Development.

Strong interest and fair knowledge are required on the international and national climate policy, including national mitigation and adaptation planning, scenario analysis on greenhouse gas emission, governance and law on climate change, carbon market mechanisms, and nature-based solutions.

Double Degree with the University of Tokyo

UNU-IAS and the Department of Urban Engineering in the Graduate School of Engineering at the University of Tokyo offer a double master's degree programme. Students first spend two years at the University of Tokyo, obtaining a Master of Engineering degree. After graduating from the University of Tokyo, students enroll at UNU-IAS for one year to obtain a Master of Science in Sustainability degree. The total amount of time required for this double degree programme is **three years**.

If you wish to enroll in this double degree programme, you must be accepted to both master's degree programmes (the UNU-IAS MSc in Sustainability, and the Master of Engineering offered by the University of Tokyo). Information on the Master of Engineering degree is available from the University of Tokyo [website](#). Please note that each university has different admission requirements and application deadlines.

Joint Diploma Programmes

Students of the UNU-IAS master's degree programme are also encouraged to pursue one of two joint diplomas in sustainability science, which are offered in partnership with the University of Tokyo Graduate School of Frontier Sciences (UT-GSFS), and with Sophia University. These diploma programmes require students to gain 34 credits, of which eight must be from courses specified by UNU-IAS and the partner university under the respective joint diploma programme. A joint diploma can only be awarded to students who successfully complete the two-year UNU-IAS master's degree programme.

Learning Environment

UNU-IAS is a global university located in Tokyo, with all classes conducted in English. Sharing a building with many UN agencies, it offers a unique learning environment for its diverse and international student body. The master's degree programme includes courses featuring more than 15 international guest lecturers from leading agencies and institutions, providing students with opportunities to learn from their unique expertise and experience. The class sizes are sufficiently small and students benefit from interactive and personalized teaching.

Facilities

The [UNU Library](#) offers access to over 27,000 academic books and a range of electronic resources including eBooks, e-Journals, and UN related materials. All students are provided with a comprehensive library orientation session at the beginning of the course. Students also have access to the libraries of International Christian University, Ochanomizu University, Sophia University, Temple University Japan, and the National Graduate Institute for Policy Studies.

II. Admissions Policy and Requirements

1. Admissions Policy

The UNU-IAS Master of Science in Sustainability Programme seeks students with the following qualities:

1. Students who possess a firm academic interest in the pressing global issues on the UN agenda, in particular those of sustainability, and a strong desire to contribute to the solving of problems concerning global environment and society through a transdisciplinary approach;
2. Students who have adequate research skills and clear questions related to global issues as well as a strong desire to engage in research in UNU-IAS thematic areas, with the potential and motivation to succeed in our programme;
3. Students who have the intention to proactively apply academic research findings to policymaking, and aim to pursue careers in international fields in public service or private organisations, including United Nations, multinational corporations, and non-governmental organisations as well as research academic institutions.

2. Admissions Requirements

Applicants for the Master of Science in Sustainability are required to have met the following requirements by the application deadline in order to be considered. Those who wish to participate in the double degree programme of UNU-IAS and the University of Tokyo (Department of Urban Engineering in the Graduate School of Engineering) must be shortlisted by the University of Tokyo before submitting an application to UNU-IAS.

- A completed bachelor's degree (or equivalent) from a recognised university or institution of higher education in a field related to sustainability in accordance with the UNU-IAS thematic areas (those who expect to receive a bachelor's degree or its equivalent conferred before the entrance period of September 2023 may also apply);
- A GPA of 2.8 or above on a 4.0 scale (equivalent to 70 % on a 100 % scale) for the bachelor's degree earned; and
- English language proficiency (*).
 - 600 on TOEFL – Paper-Based Testing (PBT) OR
 - 100 on TOEFL – Internet-Based Testing (IBT) OR
 - 7.0 on IELTS – Academic format

(Please note that TOEFL and IELTS test scores are valid for two years. Invalid test scores will not be accepted. IELTS Indicator (7.0 and above) and TOEFL iBT Home Edition (100 and above) may be accepted for those who reside in a country where either IELTS or TOEFL test services are not provided due to the COVID-19 pandemic.*

UNU-IAS requires original TOEFL/IELTS score reports (no photocopies accepted).

III. Application Procedure

1. How To Apply

All applicants:

1. Review the checklist below and prepare the application materials.
2. Register Online <https://forms.office.com/r/9axRahVPrx>
3. Receive an email from UNU-IAS Admissions Office with a link to the Application Form.
4. Submit the Application Form by the deadline* **(17 February 2023)**.
5. Receive an automatic email to confirm that the Admissions Office has received your application.

Applicants who have been shortlisted for an interview:

6. Receive an email regarding when and how to submit the required supporting documents.
7. Submit the supporting documents via email by the deadline **(Expected to be late March-Early April 2023)**.
8. Referees will receive an e-mail from the Admission Office with a request to provide the reference by the deadline* **(Expected to be late March – Early April 2023)**.

*After the applicant submits the Application Form, referees will receive an email from the Admissions Office to notify that they have been registered as referees. Only in case the applicant has been shortlisted for an interview, referees will be directly contacted by the Admissions Office regarding the request for providing reference by the deadline **(Expected to be late March-Early April 2023)**. **Applicants are not allowed to send reference letters to the Admissions Office. Please ensure that the referees send reference letters directly to the Admissions Office.**

2. Application Checklist

The Application Form may take you at least 120 minutes to fill in and it must be completed in English. The Application Form is composed of 12 sections of questions and essays. There are back/next buttons at the bottom of each section in the Form, which enable you to go back to previous sections to edit the answered boxes **before** you click the submit button at the end of the form.

The application must be done in one sitting – you cannot save your application and continue it later. Before you start filling out your Application Form, please gather all necessary materials listed below and make sure to have all of them ready to fill in the Form.

Section 1. Applicant Details *

- Personal details (name, gender, birth date, email, telephone, address etc)
- Number of your personal identification document (Passport number, national identification number etc)

* Those who wish to apply for the [Double Degree programme](#) of UNU-IAS and the University of Tokyo (Department of Urban Engineering in the Graduate School of

Engineering) will be required to fill in the date of acceptance to the master's degree programme at the University of Tokyo as a candidate for the Double Degree programme.

- Abstract of Research Proposal (Word limit: 250)
- Personal achievements (Word limit: 500)
Please describe your personal achievements including extracurricular activities, volunteer work, leadership experience, awards you have received as well as why you think they are important.

*IELTS Indicator (7.0 and above) and TOEFL iBT Home Edition (100 and above) may be accepted for those who reside in a country where either IELTS or TOEFL test services are not provided due to the COVID-19 pandemic.

Section 6. References (Two Letters of Recommendations)

Two referees' details (Type of reference – academic or professional, name, position, organisation, email, address, telephone) *

* Your referees will be required to submit reference letters only in case you have been shortlisted for an interview. Register two referees, at least one of whom must provide academic reference. The academic referee is expected to assess the applicant's academic competency in pursuing a master's degree programme. Referees should not be family members or friends.

UNU-IAS reserves the right to contact your referees. After you submit the Application Form, referees will receive an email from the Admissions Office to notify that they have been registered as referees. They will also be informed of when and how to submit references for your application. Please note that your referees will NOT have access to view your Application Form. In case you have been shortlisted for an interview, **please ensure that the referees send reference letters directly to the Admissions Office only when requested.** Applicants are NOT allowed to send reference letters to the Admissions Office. **Before you apply, please make sure to contact your referees to ask for their approval of providing references at the time UNU-IAS requests.**

* **There is no separate application for the scholarship through UNU-IAS at the time of application.**

* There are eligibility requirements to become a candidate of each scholarship and applicants must submit several additional documents for the scholarship when

shortlisted for an interview.

* **The scholarships available at UNU-IAS are very competitive and limited.**

Only highly qualified candidates from developing countries who can demonstrate the need for financial assistance will be considered for financial support. **In the case the scholarship is not available, an applicant must find own funding to be enrolled.**

* Applicants who intend to pursue a second master's degree at UNU-IAS are NOT eligible for the ADB-JSP, JFUNU, UNU Rector's and Resona Bank scholarships.

* If you are applying for any other scholarships provided by other organizations on your own, there is no need to submit the justification essay.

3. Supporting Documents (Shortlisted applicants only)

Only applicants who have been shortlisted for interviews will be required to submit the following supporting documents by email. The deadline for the submission of supporting documents will be set out **within less than one week** after shortlisted applicants receive the announcement emails from the Admissions office. Please ensure all documents are prepared and collected at the time of submitting the Application Form. Any documents that are not written in English must be accompanied by an official or certified translation in English. The translation may be provided by a school, public notary, or professional translation services.

1) Personal Identification Document

The document must be issued by the national government such as passports, birth certificates, Japanese residence card (if applicable) which validates your legal name, nationality, and residential status.

2) Transcript(s)

The transcripts must set out the list of courses/modules studied as well as grades obtained at all undergraduate and postgraduate education and include the institutional seal or signature. For those who have transferred between institutions, transcripts from both institutions must be submitted.

3) Proof of Awarded Degree

The degree certificate must certify the awarded degree and the conferred date (Bachelor's and/or higher degree).

4) Proof of Expected Graduation and Student Registration Certificate (if applicable)

If the applicants expect to earn a bachelor's degree or higher by mid-August 2023, the official letter/certificate must be issued by the institution stating that the applicant's enrolment (registration) status in the degree programme and the date of expected graduation. It is the applicant's responsibility to check that the expected graduation date on the letter is accurate and is by mid-August 2023.

5) Additional Documents for Scholarship Application, or a Letter from the Sponsor (if applicable)

All applicants who wish to apply for scholarships are required to submit CV. Please check other required documents at the [website](#).

6) Proof of English Language Proficiency *

- IELTS, TOEFL PBT, TOEFL iBT, TOEFL iBT Home Edition: Official score report
- IELTS Indicator: Screenshot of the applicant's account page or the email from IELTS Indicator that indicates the score result and the 15-digit Indicator Score ID.

* Please see the requirements stated in **page 4 and 5**.

Official scores of required test must be directly reported to UNU-IAS by the testing centres. Only valid score of each test is acceptable; the validity of both TOEFL and IELTS is for two years. Expired scores will not be accepted.

IELTS Indicator (7.0 and above) and TOEFL iBT Home Edition (100 and above) may be accepted for those who reside in a country where either IELTS or TOEFL test services are not provided due to the COVID-19 pandemic.

7) Two Letters of Recommendation

Referees will be contacted directly by UNU-IAS to provide reference. Applicants are not allowed to send reference letters to the Admissions Office.

4. Application Deadline

17 February 2023 (23:59 Japan Standard Time)

Any inquiries after the deadline regarding unsuccessful submissions due to any personal circumstances including the technical difficulties will not be accepted. Please ensure that you start your application ahead of time.

5. Key Dates *

17 February 2023: Deadline for applications

Late March-Early April 2023: Invitation to an interview and requests for submitting supporting documents by email only to the shortlisted applicants

Mid-April 2023: Interviews (Shortlisted applicants only)

Late May 2023 onwards: Announcement of application results only to the successful applicants

* The above timelines are subject to change.

6. Receipt of Application

Applicants will receive an automatic email from the Admissions Office within 24 hours to confirm the receipt of Application Form. The Admissions Office may at any time require applicants to provide verification of the information and documents provided as part of Application Forms and/or interviews.

7. Selection and Announcement of Results

After the deadline, only shortlisted applicants will be contacted by email regarding the invitation to an interview. Please ensure that you do not contact the Admissions Office to inquire about the status of your application unless you have been individually contacted by the Admissions Office.

- The successful applicants who are offered a place for the master's degree programme **will be notified by email** to the address provided on Application Form. Necessary documents for the admission procedure will be sent together with a letter of acceptance. **To secure admission, successful applicants will be required to submit those necessary documents** stated under the Conditions of Acceptance in page 12, and to pay **at least 50% of the tuition fees** for the first academic year **(5,000 USD, non-refundable) within 10 UNU working days** after result announcement and prior to enrolment. **Please see further information in the next section of IV. Enrolment Procedures.**
- **Unsuccessful applicants for will NOT be individually notified via email nor telephone by the Admissions Office. If you do not receive any emails from the Admissions Office regarding your application by the end of June 2023, your application has been unsuccessful. The Admissions Office does not provide individual feedback on unsuccessful applications.**
- Emails will be the primary method of contact. Therefore, it is essential for all applicants to list a valid e-mail address in the Application Form and regularly check their e-mail. Please ensure that e-mails from UNU-IAS (ias.admissions@unu.edu) are not filtered into the spam or junk folder. UNU-IAS will not be held responsible for unread e-mail communication.

IV. Enrolment Procedures (Successful applicants only)

1. Date of Enrolment

Date of Enrolment: 1 September 2023

The date of enrolment cannot be extended, regardless of any special circumstances of the student.

2. Conditions of Admission

Successful applicants will be requested to submit the following documents by post:

- Sealed transcript
- Certified copies of degree certificate(s)
Successful applicants who have not yet graduated from their current universities at the time of result announcement should submit the transcript and the degree certificate by the deadline that will be notified by the Admissions Office.
- Medical report
The format will be provided by the Admissions Office.

In addition, the following documents will be required to submit:

- Signed Student Contract and Student Conduct Document
- Signed document of the term of reference for the scholarship (if applicable)

Successful applicants must submit all the necessary official documents to Admissions Office **by the matriculation deadline (Early August) prior to the enrolment**. Without submission of those documents include above-listed documents as well as other requested official university documents of contract and conduct, an offer will not be completed, and applicants are not permitted to enroll in the UNU-IAS.

3. Fees

Application Processing Fee: **None**
Tuition Fee: **USD 10,000 per year** ^(*1)

To secure admission, successful applicants will be required to pay at least 50% of the tuition fee for the first academic year (**USD 5,000, non-refundable**) **within 10 UNU working days**^{*2} after the result announcement and prior to enrolment. Students who choose to pay annually must make a full one-year tuition payment before the commencement of the academic year. Successful applicants are required to submit all documents and pay the tuition fees by the deadline.

The estimated total expenses for living and studying in Tokyo for two years are approximately **USD**

56,000, including tuition fees. Applicants must ensure adequate financial resources to meet the full costs of educational and living expenses.

- All Application Forms must be typed and filled out in English. No handwritten or incomplete application documents will be considered.
- All materials and documents submitted as part of an application become the property of UNU- IAS and cannot be returned.

- Unsuccessful applicants from previous years who reapply for admission must submit a completely new set of application documents, including letters of reference. No previous application materials will act as a supporting document.
- Please ensure that the Application Form only once. If multiple Application Forms are submitted by one applicant, the latest form received will be considered the application. Earlier versions will be disregarded.
- Those who wish to withdraw from the application process must immediately contact the Admissions Office via the [Inquiry Form](#).
